Introduction

THE OSGOODE SOCIETY WAS INCORPORATED IN MAY OF 1979. IN 1993 IT BECAME THE OSGOODE SOCIETY FOR CANADIAN LEGAL HISTORY. FOUNDED AT THE INITIATIVE OF R. ROY MCMURTRY, A FORMER ATTORNEY GENERAL AND CHIEF JUSTICE OF ONTARIO, AND OFFICIALS OF THE LAW SOCIETY OF UPPER CANADA, ITS PURPOSE IS TO STUDY AND PROMOTE PUBLIC INTEREST IN THE HISTORY OF THE LAW, THE LEGAL PROFESSION AND THE JUDICIARY IN ONTARIO AND ELSEWHERE IN CANADA AND TO STIMULATE RESEARCH AND PUBLICATION ON THESE SUBJECTS.

Editor's Report

It was a particular pleasure to play the role of master of ceremonies at our book launch at Osgoode Hall on October 30th, 2013. A very large crowd – more than permitted by fire regulations! - turned out to celebrate our four new books, particularly to mark the publication of our members' book, Roy McMurtry's Memoirs and Reflections. The Osgoode Society was started by Roy McMurtry when he was Attorney-General of Ontario, in 1979, and has flourished under the Presidency of first Brendan O'Brien and more latterly Mr. McMurtry himself. His Memoirs are in themselves a legal history of Ontario and Canada over more than 50 years, and it was fitting indeed that we should publish them. In a very short time this has also become our best ever selling book, thereby boosting our membership. The Society, I am pleased to report, is in exceptionally good shape.

In 2013 our publication programme produced an additional three first class books (discussed below), rich in their variety and of first rate scholarly quality. My thanks go to those who make my job as editor-in-chief so much easier – our Associate Editor, Professor Philip Girard of Osgoode Hall Law School, and our administrator/maid of all work

Marilyn MacFarlane. The Society's directors are an invaluable source of support and advice, and as always we are deeply indebted to the Law Foundation of Ontario.

Our other very important program is the oral history collection, which grows steadily every year. We have now interviewed over 600 people, and are always receptive to members' suggestions about who we should include. We are continuing with cooperative ventures with the judges of the Ontario Court of Justice and the Advocates Society, and also keeping up and expanding the range of our interviews with lawyers who practise on 'Main Street not Bay Street.'

A full listing of all our oral histories is on the newly redesigned website, as are all our books and much else besides. I remind members that their memberships can be renewed on line now as well. No more searching for that chequebook – a few key strokes and you are at www.osgoodesociety.ca.

I look forward to another great year with what I now describe, wherever possible and with no exaggeration, as 'the most successful legalhistorical organisation in the common law world'.

The Publishing Programme

In 2013 The Society published four books.

ANNUAL BOOK

Memoirs and Reflections, by Roy McMurtry published by the University of Toronto Press.

In addition to his most important accomplishment, the founding of the Osgoode Society, Roy McMurtry recounts and reflects on his years as a criminal defence lawyer, attorney-general of Ontario, High Commissioner to the UK, and Chief Justice of Ontario, and his involvements in many other events and causes. Along the way we are given insights into the patriation of the Constitution, the end of apartheid in South Africa, the Dubin Inquiry, and other milestones. This book is a great read, a modern legal history of Canada and Ontario, and a compelling story of a life well lived.

OPTIONAL EXTRAS

We offered members *three* optional extras.

1. Lawyers, Families, and Businesses: The Shaping of a Bay Street Law Firm, Faskens, 1863-1963, by C. Ian Kyer, Lawyer and Historian, published by Irwin Law.

Ian Kyer has combined his historical and legal expertise to produce a comprehensive account of the first century of Faskens. He takes us through crucial stages in the development of not just this but many other Canadian law firms - alliances with business, the growth of two or three man partnerships into considerably larger firms, and the links between leading firms and politics. Along the way we see how law practice changed, how remuneration was divided up, how strong leaders stamped their

individual personalities on the collective identity of the firm. This is a major contribution to our understanding of the seismic changes in Canadian law practice.

2. The Massey Murder: A Maid, Her Master and the Trial that Shocked the Nation, by Charlotte Gray, Independent Historian, published by Harper Collins.

In 1915 Carrie Davies, an 18-year old servant girl in the home of Charles (Bert) Massey, scion of the famous Massey family, shot and killed her employer as he entered his house after work. Remarkably, she was acquitted, and award winning popular historian Charlotte Gray explains how this happened. Vividly recreating the war time atmosphere, a press war, and conflicts over crime and gender, she highlights the role played by the defence lawyer who exploited the "unwritten law" of an honour killing in a rare Canadian case of jury nullification.

3. Essays in the History of Canadian Law – Volume XI: The Canadas, edited by G. Blaine Baker, Emeritus Professor Law, McGill University, and Donald Fyson, Professor of History, Laval University. Published by the University of Toronto Press.

This latest volume in the Essays in the History of Canadian Law series, with which we launched our publishing programme in 1981, is the first devoted to central Canada - what is now Ontario and Quebec before Confederation. Anchored by a comprehensive introduction exploring the main themes of the legal history of the region, a group of distinguished historians from have contributed 11 substantive essays (three in French), on subjects as varied as women in court, grand juries, western law and aboriginal peoples, gun use and control, Quebec legal literature, married women's property, and imprisonment for debt.

ANNUAL BOOK

The Court of Appeal for Ontario: Defining the Right of Appeal 1792-2013, by Christopher Moore, published by the University of Toronto Press.

Christopher Moore's study of the Ontario Court of Appeal begins with the establishment in 1850 of the Court of Error and Appeal for Canada West and takes us through more than 150 years of institutional history, charting the various and at times complex reorganisations of the court and identifying landmark events, such as the opening up of criminal appeals in the late nineteenth century. This is also partly a biographical history, analysing its dominant personalities. Along the way the book looks at the court's workload, its internal administration, relations with the bar, and connections to the politics of the province.

OPTIONAL EXTRAS

1. Equality Deferred: Sex Discrimination and British Columbia's Human Rights State, 1953-1984, by Dominique Clement, published by University of British Columbia Press.

Professor Clement's pioneering study combines the modern history of the rise of human rights with a detailed study of an administrative agency. It focuses particularly on sex discrimination, and documents the political debates surrounding human rights law, analyses the role of social movements in developing the law, and discusses the working of the tribunals and human rights investigators who put the law into practice.

2. Petty Justice: Low Law and the Sessions System in Charlotte County, NB 1785-1867, by Paul Craven, published by the University of Toronto

Press.

Local administration and law enforcement in pre-Confederation Canada was largely done through a coterie of appointed officials, most notably the justices of the peace, but also including constables, parish officers, overseers of the poor, and the like. This system, inherited from Britain, has not previously been closely examined for Canada, and Paul Craven's masterful study of its operation and decline is thus a landmark in our legal history. In a remarkably deeply researched study of one county, Craven explains how the system worked, who used it, and how private and public roles and interests overlapped and interacted.

3. Ruin and Redemption: The Struggle for a Canadian Bankruptcy Law, 1867-1919, by Thomas Telfer, published by the University of Toronto Press.

Professor Telfer's deeply researched book shows that between Confederation and 1919, when the federal parliament passed the Bankruptcy Act that remains the basis of the current law, Canadians debated insolvency law with a perhaps surprising amount of passion. The discharge raised deep issues of commercial morality, while arguments about priorities pitted local against regional and national interests. Federalism complicated the story, as it often does in Canadian legal history, as the federal parliament abandoned its jurisdiction over bankruptcy for decades.

Awards

The Society offers or administers a number of awards.

R. Roy McMurtry Fellowship. In 2013 we awarded the sixth R. Roy McMurtry Fellowship in Canadian Legal History. This fellowship was created on the occasion of the retirement as Chief Justice of Ontario of the Hon. R. Roy McMurtry. It honours the contribution to Canadian legal history of the founder of the Osgoode Society for Canadian Legal History and its current President. The fellowship was established by Chief Justice McMurtry's friends and colleagues, and endowed by private donations and the Law Foundation of Ontario. The fellowship is to support graduate (preferably doctoral) students or those with a recently completed doctorate, to conduct research in Canadian legal history, for one year. The 2013 co-winners were Edward Cavanagh, a PhD student at the University Ottawa who is working on the history of chartered companies in Canada, with specific reference to their role in land settlement and the development of doctrines related to aboriginal dispossession. And Joseph Dunlop, who recently obtained his PhD from Oxford, and will be a Fellow at Emanuel College, University of Toronto working on the role played by Catholic politicians in the various law reforms related to sexuality in the 1960s and 1970s.

The Osgoode Society congratulates the winners, chosen from a very strong field of applicants, and is delighted that the fellowship has been awarded to such worthy researchers.

Peter Oliver Prize. The Peter Oliver Prize in Canadian Legal History is named for the Society's founding editor-in-chief, and awarded annually for published work in Canadian legal history written by a student. Students in any discipline and at any stage

of their careers are eligible. The co-winners for 2013 were Susan McKelvey, 'Creating the Myth of Raceless Justice in the Murder Trial of R. v. Richardson, Sandwich, 1903,' and David Steeves, Maniacal Murderer or Death Dealing Car: The Case of Daniel Perry Samson, 1933-1935. Both essays were published in Barrington Walker's, ed., The African Canadian Legal Odyssey: Historical Essays.

John T. Saywell Prize for Canadian Constitutional Legal History. This prize, established through the generosity of Professor Saywell's son John MacIntosh and in recognition of Professor Saywell's life-long commitment to the highest standards of scholarship in Canadian history and law, is given biannually to the best new book in Canadian legal history, broadly defined, that makes an important contribution to an understanding of the constitution and/or federalism.

The third winner of the Saywell Prize, for 2013, was Michael S. Cross, Professor Emeritus of History at Dalhousie University for, *The Morning Star of Memory: A Biography of Robert Baldwin*, (Oxford University Press, 2012) Professor Cross's masterful biography examines the personal and political life of the individual who, more than any other, brought the key constitutional advance of responsible government to the colonies of British North America.

Student Book Award

The Society in co-operation with Canadian law schools offers an annual book award to a graduating student deemed to have done excellent work in legal history. The Society provides one book from its back list and a current membership, including the annual publication, to such a student in each participating Canadian Law School.

Graduate Student Assistance Programme

The Society continues its Graduate Student Assistance programme intended to offer some financial assistance to graduate students doing research in Canadian legal history to travel to outof-town archives. Applications are invited.

Research Support Programme

The Society in 2013 made the following grants: Charles Hoffman, \$1,000.00 for travel from Montreal to Ottawa for research at Library and Archives Canada.

Patrick Connor, \$2,000.00 for data entry of research into the history of crime and punishment in Upper Canada.

The Society's Oral History Programme is a unique and invaluable source of information on all aspects of our legal past. The interviews have been used extensively in scholarly research and the programme has gained a wide reputation across Canada and beyond for the quality and scope of its work. Several of our programmes are privately funded, for example by law firms, judges' associations etc., and we are pleased to discuss possible sponsorship with interested parties.

We have been privileged over the past several years to have co-sponsored oral history programmes with several bodies and organizations. We thank the following: The Advocates' Society and The Ontario Conference of Judges.

From the programme's inception, most of the interviews have been carried out by Christine Kates. For the past few years we have also been fortunate to be able to employ the skills of Cynthia Smith. We are now using a third interviewer, Rosemary Legris. The assistance of volunteer interviewers remains important. If you wish to act as a volunteer interviewer, please contact the Society.

The number of legal professionals interviewed through the programme since 1979 now totals 584, with approximately 90,300 pages of transcript. For a complete listing of all interviews conducted for the Osgoode Society oral history programme, please contact Marilyn MacFarlane at mmacfarl@lsuc.on.ca.

Report on the Financial Statements

NOTES TO FINANCIAL STATEMENTS

FOR THE YEAR ENDED DECEMBER 31, 2013

PURPOSE OF THE ORGANIZATION

The Society was formed to study and promote public interest in the history of the law, the legal profession and the judiciary in Ontario and elsewhere in Canada and to stimulate research and publication on these subjects.

The Society meets these objectives by publishing books on Canadian legal history, sponsoring the collection of oral histories from individuals within the legal community, maintaining a website devoted to Canadian legal history, providing research and publication grants, and sponsoring and hosting legal history seminars.

The Society is incorporated, without share capital, under Letters Patent. The Society has been granted tax exempt status as a charitable organization under the Income Tax Act of Canada (the "Act"). In order to maintain the exempt status under the Act, the Society must meet certain requirements within the Act. In the opinion of management, these requirements have been met.

1. SIGNIFICANT ACCOUNTING POLICIES

These financial statements were prepared in accordance with Canadian Accounting Standards for Not-for-Profit Organizations and are in accordance with Canadian generally accepted accounting principles.

(a) Fund accounting

The Association uses fund accounting. General activities are reflected in the General Fund.

(b) Investments

Investments consist of Guaranteed Investment Certificates. Investments are initially recorded at cost with interest recorded as earned.

(c) Publication inventory

Inventory, which consists of books available for sale, is carried at the lower of cost and net realizable value, as measured using the specific identification method

(d) Capital assets

Capital assets are recorded at cost. Amortization is provided annually at rates calculated to write off the assets over their estimated useful lives as follows:

Office equipment 20% declining balance Computer equipment 45% declining balance

(e) Financial instruments

The Society's financial instruments comprise cash, investments, receivables, accounts payable and accrued liabilities, and deferred contributions.

Cash, receivables, accounts payable and accrued liabilities, and deferred contributions are reported at the fair value at the balance sheet date, which equates to the carrying value.

1. SIGNIFICANT ACCOUNTING POLICIES, continued

(f) Revenue recognition

Revenue is recognized when it is received or receivable, if the amount can be reasonably estimated and if collection is reasonably assured. Deferred revenue represents the portion of grants not yet expended as required.

Membership fees are recognized as revenue when application for membership is received. Each member is entitled to receive the 'membership book' of the year as part of their membership fee.

Grants are recognized as revenue in the period to which they relate, or when costs for which the funds were granted are expensed.

Book sales are recognized as revenue when the books are shipped.

Fundraising is recognized as revenue when it is received.

Donations are recognized as revenue when received.

Investment income is recognized as revenue in period in which it is earned.

(g) Cash and cash equivalents

The Society considers deposits in banks and investments in certificates of deposit as cash and cash equivalents.

(h) Contributed goods and services

Volunteers contribute numerous hours each year to assist the Society in carrying out its activities. The fair value of the contributed services cannot be reasonably estimated and is not recognized in the financial statements.

The Law Society of Upper Canada provides office services to the Society, including rent, telephone and computer assistance, the fair market value of which is not readily available. As such, the value recorded is the amount actually paid.

2. STUART THOM FUND AND STUART THOM SPECIAL PROJECTS FUND

The Stuart Thom Fund was established in 1998 from funds donated by the Thom family and from a portion of net assets restricted by the Board of Directors. For ease and efficiency of managing the investments, these funds have been commingled with the Society's investments (see Note 6).

The Society is entitled to use the investment income from The Stuart Thom Fund for its operations. At its discretion, the Board of Directors may allocate investment income and any other amounts, to the Fund. For fiscal 2013, no investment income (2012 - \$nil) was allocated to the Stuart Thom Fund. \$65,380 of net assets were transferred to General Fund to fund the deficit incurred in the year.

The Stuart Thom Special Projects Fund was established by the Board of Directors in 2009 and represents an allocation of net assets previously restricted by the Board as part of the Stuart Thom Fund. This fund is to be used for projects that significantly advance the mission of the Society, to a maximum of \$30,000 per annum. For ease and efficiency of managing the investments, these funds have been commingled with the Society's investments.

2. STUART THOM FUND AND STUART THOM SPECIAL PROJECTS FUND, continued

The Society is entitled to use the investment income from The Stuart Thom Special Projects Fund for its operations. At its discretion, the Board of Directors may allocate investment income and any other amounts to the Fund. For fiscal 2013 no investment income (2012 - \$Nil) was allocated to the Stuart Thom Special Projects Fund.

3. PETER OLIVER MEMORIAL STUDENT FUND

The Peter Oliver Memorial Student Fund was created by the Society in 2006 to provide an annual award for published work by a student, or students, in the field of Canadian legal history. The award includes a copy of the current year's publication, a copy of the Peter Oliver Essay volume and any five books from the back publications list.

4. JOHN T. SAYWELL PRIZE FUND

The John T. Saywell Prize for Canadian Constitutional Legal History ("Saywell Prize") was created in 2008. An award of \$2,000 is granted bi-annually to the best new book in Canadian legal history which makes an important contribution to an understanding of the constitution and or federalism. The prize is to be funded from investment income on a \$25,000 endowment and related restricted contributions.

The \$25,000 contribution received in 2008 for the Saywell Endowment Fund is subject to externally imposed restrictions stipulating that the resource is to be maintained permanently. Investment income on this balance is restricted to fund the John T. Saywell Prize for Canadian Constitutional Legal History and is included in revenue of the John T. Saywell Prize Fund.

The funds for the Saywell Prize and Saywell Endowment are invested in Guaranteed Investment Certificates, maturing August 17, 2015, earning interest at 1.5%.

5. HONOURABLE R. ROY MCMURTRY LEGAL HISTORY FELLOWSHIP FUND

The Honourable R. Roy McMurtry Legal History Fellowship (the "McMurtry Fellowship") was established by the Society in 2006 to enable students and post-doctoral candidates in Canadian legal history to undertake or continue their studies, writing and research in the field.

Investment income earned on the funds represent restricted contributions to the fellowship.

The Law Society Foundation has agreed to provide an annual contribution to the McMurtry Fund of \$6,000, ending in 2015.

During the year the Directors chose to pay \$6,500 of the \$16,000 award from the McMurtry Fund with the balance, or \$9500, paid from the Thom Fund for Special Projects.

Under the terms of an Investment Services Agreement between Osgoode and the Law Society of Upper Canada (LSUC), LSUC manages the investments related to the McMurtry Fellowship.

6. INVESTMENTS

Investments are carried at cost plus interest accrued to the balance sheet date.

Investments for the General Fund, Stuart Thom Fund, Stuart Thom Special Projects Fund and Peter Oliver Memorial Student Fund are commingled for ease of management. These investments consist of Guaranteed Investment Certificates, maturing January 20, 2014 and earning rates of interest of 1.1% and 1.6%.

Investments for the Saywell Prize Fund consist of a Guaranteed Investment Certificate, maturing August 17, 2015, earning interest at 1.5%.

Investments for the Saywell Endowment consist of a Guaranteed Investment Certificate, maturing August 17, 2015, earning interest at 1.5%.

Investments of The Honourable R. Roy McMurtry Legal History Fellowship (the "McMurtry Fellowship") consist of a Guaranteed Investment Certificate, maturing September 6, 2015. The GIC earns interest of 1.3% in the first year and 1.55% in the second year.

7. PUBLICATION INVENTORY

Included in publication programme costs is a write down of \$36,538 (2012 - \$37,700) required to reflect inventory at the lower of cost and net realizable value.

9. RELATED PARTY TRANSACTIONS

During the year the Society paid \$10,000 as research support on behalf of a Director of the Society. The transaction was recorded at the exchange value.

COMMITMENTS

The Society fulfills its mandate in part through providing research grants. As at December 31, 2013, the Society has outstanding commitments totaling \$3,308 (2012 - \$6,155) to be expended on research and related projects.

A contract has been signed for the purchase of future publications in the amount of \$12,000. The balance of contracts for the 2014 publications are still in negotiations.

The Society is party to an agreement to produce a publication planned for the 2014 year. The agreement requires a final payment of \$25,000 be made in 2014. Funding for the project has been secured through a grant from the Law Foundation of Ontario.

These amounts have not been recognized as a liability of the Society as the terms requiring payment have not been met.

11. FINANCIAL INSTRUMENTS

The Society's financial investments comprise short term deposits, the main purpose of which is to provide financing for the organization's activities. It is the Society's policy that investments are redeemed as cash flow dictates. The Society has various other financial assets and liabilities such as accounts receivables and accounts payables, which arise directly from operations. The main risk arising from the Society's financial instruments are interest rate risk and credit risk.

(a) Interest Rate Risk Exposure

Exposure to the risk of changes in market interest rates relates to the Society's cash and investment balances. The Society manages this risk by investing in fixed rate investment instruments.

(b) Credit Risk Exposure

Credit risk on the financial assets of the Society equates to the carrying amount. The Society carries receivables from members of the organization and recognized third parties. Receivable balances are monitored on a regular basis to minimize the exposure to bad debt. Credit risk associated with cash and investments is limited to the risk of default by the counter party, with a maximum exposure equal to the carrying amount of these assets.
